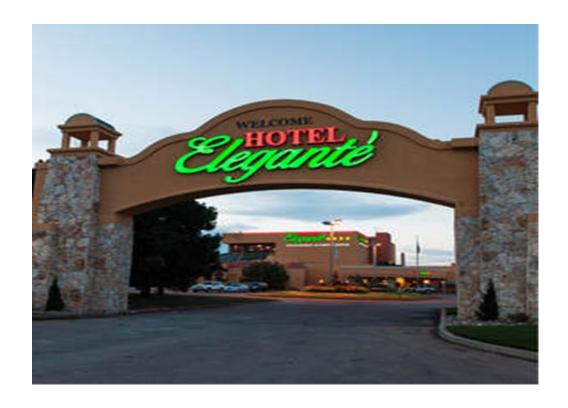

Article III. Section 3.2 / 4

Current: It shall be the duty of the Secretary to keep the minutes of the meetings of the Corporation, and the Board of Directors meetings, and any other meetings that may be called to distribute the minutes of the meeting as directed by the Board, to distribute the minutes of the meeting as directed by the Board, and to perform other secretarial duties as needed. The Secretary shall send written or printed notice stating the place, day and hour for any meeting of members, either personally or by mail, fax, or ACSES mail, to each member entitled to vote at such meeting at least ten (10) days prior to a meeting. The Secretary shall serve as the Registered Agent for service of process of the Corporation. The Secretary shall notify promptly the appropriate governmental agencies of any changes of the name and address of the Registered Agent.

Proposed: It shall be the duty of the Secretary to keep the minutes of the meetings of the Corporation, and the Board of Directors meetings, and any other meetings that may be called to distribute the minutes of the meeting as directed by the Board, to distribute the minutes of the meeting as directed by the Board, and to perform other secretarial duties as needed. The Secretary shall send written or printed notice stating the place, day and hour for any meeting of members, either personally or by mail, fax, e-mail or ACSES mail, to each member entitled to vote at such meeting at least ten (10) days prior to a meeting. The Secretary shall serve as the Registered Agent for service of process of the Corporation. The Secretary shall notify promptly the appropriate governmental agencies of any changes of the name and address of the Registered Agent.

Article II, Section 2.5

Current: At least two months prior to the annual meeting of the members of the Corporation, the President-Elect shall appoint and chair a Nominating Committee. The Nominating Committee shall have no more than three (3) members, including the President-Elect. Nominating Committee Members cannot be nominated for an Officer's position on the new Board of Directors.

Proposed: At least two months prior to the annual meeting of the members of the Corporation, the President-Elect may appoint and chair a Nominating Committee. The Nominating Committee shall have no more than three (3) members, including the President-Elect. Nominating Committee Members cannot be nominated for an Officer's position on the new Board of Directors.

No more than three (3) employees from any one entity shall serve as officers.

Proposed:

Add new (a): For purposes of this section, a vendor shall be considered a separate entity from the county in which it is located.

Current: The Officers shall be elected by the General Membership at the annual General Membership Business Meeting of the corporation, by validated ballot vote. Ballots shall be collected, validated and counted by three non-board members.

Proposed: The Officers shall be elected by the General Membership at the annual General Membership Business Meeting of the corporation, by validated ballot vote. Ballots shall be collected, validated and counted by at least two non-board members.

Article II, Section 3

Current: At the first meeting of the newly elected Board of Directors, consisting of thirteen (13) officers and Past-Presidents who have declared in writing their intent to serve on the Board, as set forth above, and additional twelve (12) Members at Large shall be selected from
