Responsibilities

Our Mission

Training Since 1974:

The Colorado Family Support Council is a non-profit corporation whose purpose is to update and train individuals and agencies on the laws and procedures related to child support establishment and enforcement.

Our Purpose

The purpose of the Colorado Family Support Council is to promote understanding of family support issues and to provide a forum for child support workers to discuss problems, solutions and further the direction of the program.

Our History

The Colorado Family Support Council was organized in 1974 under the umbrella of the Colorado District Attorney's Council (CDAC). Seed money in the amount of \$500.00 was provided to the Family Support Council by CDAC.

Since training has always been perceived as an important element in the effectiveness of the IV-D program, the council began sponsoring an annual training conference for those working in the field of child support. In addition to the annual conferences, the council has sponsored numerous regional training sessions on topics of interest. In 1985, CFSC merged its annual conference with, and became host of, the national conference in Snowmass.

In 1991 the Council incorporated as a 501(c)3

charitable organization. The purpose of the Council had to change slightly to drop lobbying efforts to keep its educational tax preference status. Donations made to CFSC are now tax deductible for many tax filers.

In 2005, the Council started its website at www.cfscinc.org to keep its membership informed of pertinent information and assist its board of directors in conducting the business of the organization.

In a relatively short period of time the council has grown to meet many needs of the child support worker and hopes to further meet those needs in conjunction with the State Office of Child Support Services and the other organizations which have formed to enhance the area of child support.

Board Members

- The Officers are elected by the General Membership at the annual General Membership Business Meeting during Conference by validated ballot vote. Ballots are collected, validated and counted by three non-board members.
- The Board of Directors consists of thirteen officers, twelve Members at Large and Past-Presidents who have declared their intent in writing to serve on the Board.
- The Officers of the Colorado Family Support Council, Inc., will be: President, President-Elect, six (6) Regional Vice-Presidents, Secretary, Treasurer, IV-D Administrator, IV-D Attorney Representative and Historian.
- The general duties of Corporate Officers are as follows:

- The President is the chief executive officer of the Board, and in general, supervises and directs the business and affairs of the Board.
- The President-Elect is responsible for the development and preparation of the program agenda for the annual conference and chairs the Agenda Committee.
- The Regional Vice-Presidents establish and maintain communication among the various counties within their region and with the Board, and to assist in other duties as needed.
- The Secretary keeps the minutes of the meetings for all meetings and distributes the minutes as directed by the Board, and to perform other secretarial duties as needed.
- The Treasurer receives, disburses and accounts for all monies and makes an annual report of the finances at the annual meeting.
- The IV-D Administrator Representative is the liaison between the Board and the I V-D Administrators and communicates and recommends information between both entities.
- The IV-D Attorney Representative is the liaison between the Board and the IV-D Attorneys and communicates and recommends information between both entities.
- The Historian maintains records of the Corporation and insures the accuracy of information distributed to the general public.
- Honorary Members are persons who, in the opinion of the Board of Directors, have performed noteworthy service to the Corporation and where such membership will add to the prestige and effectiveness of the Corporation, State, District, or County Departments of Social Services.
