CFSC Auctions by Gina Tyler

The 2015 CFSC Conference to be held in Steamboat Springs is just around the corner. Here is a reminder of the different auctions you will have an opportunity to participate in and how they work.

Silent Auction: Items for this auction will be assigned a number or a letter. If you are interested in an item you simply fill in the provided piece of paper with: the item number/letter of interest, your name, phone number, county you work in and the amount you would like to bid. Your bid slip is then placed in the cup, bag or basket that correlates to your item of interest. At the close of this auction, the person that has bid the highest is the winner of that bid.

Progressive Auction: Items for this auction will be assigned a number or a letter. If you have an interest in an item you find the correlating bid sheet for your item and provide:

Your name, phone number, county you work in and your bid amount. ** The bid sheets for items in this auction will have the item value and a minimum starting bid. You will be able to see what others are bidding and you may bid on this item as many times as you would like-the fun part is outbidding someone else (especially your co-worker!). At the close of this auction the person that has bid the highest is the winner of that bid.

LIVE auction....items for this auction will be on display several days before the actual auction(s) so everyone has the opportunity to look at all the goodies up for bid. At the start of the auction you pick up a numbered bid paddle and let the fun begin! The auctioneer will give a brief description and value of the item up for bid and start his chant.... If you are interested and like the price the auctioneer just said, you raise your paddle this will alert the auctioneer of your bid and stir some interest from others. Each time you wish to bid on an item you put up your paddle. You may bid on as many items as you wish making sure to keep your ears open to hear the amount you are bidding. The auctioneer will gear up and continue his chant to get the crowd involved and get bids coming in. Keep track of your paddle number because when you hear "Going once, going twice, sold!" that bid has closed and you could be the winner!


